

VILLAGE OF NAKUSP

BYLAW NO. 655, 2015

For the levying of rates and taxes for the Year 2015.

WHEREAS section 197 of the *Community Charter* requires that Council adopt a bylaw to establish rates on all taxable land and improvements according to their assessed value;

NOW THEREFORE the Council of the Village of Nakusp in open meeting assembled enacts as follows:


1. The following rates are hereby imposed and levied for the year 2015:
 - a) for all lawful and general purposes of the Municipality on the assessed value of land and improvements taxable for general municipal purposes, rates appearing in Column "A" of Schedule A attached hereto and forming a part hereof:
 - b) for Hospital purposes on the assessed value of land and improvements taxable for Regional Hospital District purposes, rates appearing in Column "B" of Schedule A attached hereto and forming a part hereof:
 - c) for purposes of the Regional District of Central Kootenay on the assessed value of land and improvements taxable for Regional Hospital District purposes, rates appearing in Column "C" of Schedule A attached hereto and forming a part hereof:
2. The aforesaid rates and taxes shall be considered to have been imposed on and from the First (1st) day of January 2015. Such rates and taxes are not deemed to be paid until payment is received in the office of the Collector of the Village of Nakusp at 91 – 1st Street, Nakusp, BC.
3. The minimum amount of taxation upon a parcel of real property shall be one dollar (\$1.00).
4. This bylaw may be cited as "Tax Rates 2015 Bylaw No. 655, 2015"


