## BYLAW NO. 496 - 6

### AMENDMENT TO CONTROL AND REGULATE TRAFFIC, PARKING, STREETS AND SIDEWALKS, BYLAW NO. 496, 1997

---

**WHEREAS** Council deems it necessary to amend the Village of Nakusp Control and Regulate Traffic, Parking, Streets and Sidewalks Bylaw, Bylaw No. 496;

**NOW THEREFORE** the Council of the Village of Nakusp, in open meeting assembled, enacts as follows:

1. This bylaw may be cited for all purposes as the “Control and Regulate Traffic, Parking, Streets and Sidewalks Amendment Bylaw No. 496-6, 2019”.
2. Village of Nakusp Control and Regulate Traffic, Parking, Streets and Sidewalks Amendment Bylaw No. 496-6, 2019 is amended by:
  - (a) removing all alphabetical labeling in Part II, Definitions
  - (b) adding in Part V Clause 22, subsection (a)(i), “other than cycle parking as permitted in Schedule F of this bylaw” after the word “cycle;”
  - (c) adding “Schedule F” - Permitted Locations for Cycle Parking on Broadway Avenue.
3. This bylaw shall come into effect July 24, 2019.

READ A FIRST, SECOND AND THIRD TIME this 22<sup>nd</sup> day of July, 2019.
